



## **UF Research 2021 Summer Seminar Series:**Research Integrity and the Responsible Conduct of Research

**Overview:** By participating in this seminar series, participants will gain an understanding of research integrity, the responsible conduct of research, and an overview of the UF research enterprise. Participants may enroll in one class, the whole series, or any set of classes in any combination. All classes will be held via Zoom and will last 1-2 hours, depending on the topic.
